1. Citation

These Regulations may be cited as the Transport Licensing (Fees) Regulations.

2. Fees

The fees set out in the Schedule to these Regulations shall be payable in respect of the matters specified thereunder.

3. Remittance of fees

The Minister may in his discretion in any case remit the whole or part of any fees under these Regulations.

4. Revocation

1. For a short term licence for every vehicle the use of which is authorised thereunder shall be—	
(a) where the licence is for a period not exceeding 7 days	5,000 (2,000)
(b) where the licence is for a period which exceeds 7 days	7,500 (3,500)
(c) where the licence is for a period which exceeds one month but does not exceed three months	The appropriate three months rate
2. For any variation of licence	5,000/= (3,000)
3. For lodging any application	5,000/= (500)
4. For duplicate copy of a condition card of licence	2,000/= (1,000)
5. For registration of any application for licence	2,000/= (1,000)
6. For a duplicate copy or authorization of a lost, destroyed or defaced licence	5,000/= (2,500)
7. For lodging of notice of reasons of opposing an application in accordance with section 33:	
(a) by a District or Regional Development Council	5,000/= (1,000)
(b) by a co-operative union, the National Transport Organisation controlled by a co-operative union or National Transport Corporation	(1500)
(c) by any other person	5,000/= (2000)
8. For issuing a bus timetable	2,000/= per timetable issued.
9. Premium charge for Pan-Territorial Routes:	
(a) 0-10 (number of vehicles on licence)	5,000/= (2,000)
(b) 11-30 (number of vehicles on licence)	10,000/= (6,000)
(c) over 30 (number of vehicles on licence)	15,000/= (10,000)
