(Made under sections 6 and 7)

THE VALUE ADDED TAX (EXEMPTION) (SADC TRADE FACILITY (TRF) SUPPORT TO
TANZANIA'S REGIONAL INDUSTRIAL COMPETITIVENESS THROUGH INCREASED
VALUE ADDITION AND UPGRADING OF THE SUNFLOWER VALUE CHAIN) (MINISTRY
OF INDUSTRY TRADE AND INVESTMENT) ORDER, 2019

Citation and
Commencement

1. This Order may be cited as the Value Added Tax (Exemption)(SADC Trade Facility (TRF) (Support to Tanzania's Regional Industrial Competitiveness Through Increased Value Addition and Upgrading of the Sunflower Value Chain) (Ministry of Industry Trade and Investment) Order, 2019 and shall be deemed to have come into operation on the 1st day of January, 2018.

Exemption

2. Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the value added tax payable on the goods specified in the Schedule to this Order imported or purchased prior to clearance through customs or locally purchased by or on behalf of Ministry of Industry, Trade and Investment to be used solely in the project for SADC Trade Facility (TRF) Support to Tanzania's Regional Industrial Competitiveness Through Increased Value Addition and Upgrading of the Sunflower Value Chain is hereby exempted.

Conditions

3. The exemption granted under this Order shall cease to have effect and the value added tax shall become due and be payable as if this exemption had not been made if the said goods are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.

Expiry

4. This Order shall expire on the 31st day of December, 2019.
